RELEASE AGREEMENT

This release Agreement ("Agreement") is made effective as of ____/____/____ (Date) by and between Chico Cheer All Star Elements, USASF Cheer Gym Insurance, Inc., and _____ (Parent) ("Customer(s)")

RECITALS

- A. Chico Cheer All Star Elements provides instruction and services relating to cheerleading.
- B. Customer(s) wish for _____ (Student) to receive such instructions and services and has agreed to release Chico Cheer All Star Elements as set forth below as part of the consideration for such instruction and services.

NOW, THEREFORE, the parties agree as follows:

AGREEMENT

1. Risk. Customer understands that cheerleading activities have inherent dangers that no amount of care, caution, instruction, or expertise can eliminate. Customer expressly and voluntarily assumes all risk that, subsequent to executing this Agreement, student will incur or suffer personal or bodily discomfort, loss, personal injury, disability, death, damage, or property damage, or any of these, which are in some way caused by or related to the instruction, activities, or services provided by Chico Cheer All Star Elements. Further, there is a risk that such bodily injury, discomfort, loss, bodily damage or disability, or any of these, may be more serious than the undersigned knows, expects, or anticipates.
2. Release. In consideration of the covenants and provisions of this Agreement, Customer forever releases and discharges and hold Chico Cheer All Star Elements and its affiliates, representatives, employees, attorneys, and agents of and from any and all claims, debts, liabilities, demands, obligations, promises, acts, costs and expenses (including without limitation attorney's fees and costs), injuries, damages, actions, and causes of action of whatever kind or nature including, but not limited to, the release's negligence or non-willful acts or omissions, whether known or unknown, suspected or unsuspected, in connection with or relating to the instruction, activities, or services provided to the student by the release's including travel, lodging, or other activities undertaken off-site which are sponsored by the release's. Customer agrees and acknowledges that this release applies to both known and unknown claims and, upon advice of Customer's independent legal counsel, agrees to waive the benefits of California Civil Code section 1542, and any similar federal statutes, which states as follows: A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.
3. Indemnity. Customer(s) hereby agree, jointly and severally, to indemnify, defend and hold Chico Cheer All Star Elements harmless from and against any claim, cause of action, action, damage, death, liability, obligation, expense, lien, demand, account, and/or costs (including payment of attorneys' fees and legal costs actually incurred whether or not litigation is commenced) based on, in connection with, or arising out of bodily discomfort, loss, bodily injury, disability, death, or any damage of any nature whatsoever.
4. Emergency Medical Information. Customer(s) have provided on Exhibit A attached hereto all emergency medical insurance information relevant to the student.
5. Arbitration and Attorney's Fees. In the event that any party shall bring any action, suit, or any other proceeding against any other party relating to this Agreement or the instruction, activities, or services provided to the student, whether for themselves or on behalf of the student, the parties agree for themselves and for the student that the action, suit, or other proceeding shall be determined by binding arbitration under the then existing commercial rules of the American Arbitration Association. In doing so, the parties waive for themselves and for the student certain rights, including but not limited to the rights to trial by judge or by jury, the right to appeal an adverse ruling, and the right to pre-trial discovery. The parties further agree that the prevailing party shall recover all of their reasonable attorney's fees and costs from the non-prevailing party as may be fixed by the arbitrator.
6. Integration. This Agreement constitutes a single integrated written contract expressing the entire agreement between the parties hereto relative to the subject matter hereof. This agreement supersedes all prior or contemporaneous agreements.
7. Law. This Agreement shall be governed by and shall be interpreted in accordance with California law.
8. Rules & Policies. Customer(s) agree to adhere by all the rules and policies posted in the Chico Cheer All Star Elements facility and listed on the "Rules & Regulations" hand out that is located on the web page or given to the customer(s).

PARENT/CHEERLEADR POLICY AGREEMENT

The Chico Cheer All Stars acknowledges the financial responsibilities brought forth by both cheerleaders and parents to participate in the "Cheer Camp" program. To ensure that all children are given equal opportunity to participate we ask payments to be made the first class of each month prior to the start of the class. The payments of \$75/month may be given in check, money order or cash.

In the event payments are not received the child's spot in the after school program may be forfeited or moved to the current waiting list.

LIST OF UNACCEPTABLE BEHAVIORS

The following list is not extensive, but outlines some behaviors that will not be accepted by children enrolled in our programs:

1. Use of vulgar language.
2. Physical or verbal abuse/mistreatment of one child to another OR staff.
3. Continual disregard for staff authority.
 - a. Not following directions.
 - b. Not participating in planned activities.
 - c. Not respecting the leader's authority to give time-outs for unacceptable behavior.
4. Vandalism or stealing of any CCAS property OR another child's property.

DISCIPLINE POLICY

The Chico Cheer All Stars strives to provide your children with a safe and fun environment. The following is an outline of our discipline policy for inappropriate behavior.

Violation 1: Verbal warning and when possible brief discussion with child

Violation 2: Time out (no more than 5 min) and discussion of inappropriate behavior. Staff member and child generate ideas to create desired behavior.

Violation 3: The child's parent are called and notified of the situation and the child is dismissed from the program for the remainder of the day.

Violation 4: The child's parents are notified and director/parent conference is scheduled.

You will be informed when your child misbehaves. Three early dismissals from the program during the month and the child will be suspended from the program for the remainder of the year without any refund. If unacceptable behavior continues with no sign of improvement, the child will be removed from the program.

Additional Information for your Reference

Daily Late Pick Up Fees

It is important that you pick your child up promptly by 5:00 p.m. There will be a late fee of \$5.00 every fifteen minutes after 5:00 p.m. For example if you do not pick them up until 5:07 p.m. you owe \$5.00. If they are picked up at 5:20 you owe \$10.00. This fee was set in place to encourage prompt pick up and to cover over time costs for the staff. Please avoid any late fees by planning to pick your child up on time.

Drop-In Fees

A drop in fee of \$10/day will apply for all additional days your child attends without being registered for the current month. Payments must be received by 5:00 p.m. the day your child is to attend.

Phone Call Policy

We ask that parents call our staff when their child is not going to attend the Cheer Camp Program on a regularly scheduled day. We have this phone call system in place to assure the safety of your child.
